1. Information about us

- 1.1 We operate the website <http://www.go2telecom.co.uk> ("our site").
- 1.2 We are **go2 Telecom Limited**, a company registered in England and Wales under company number 04811905. Our registered office is at **Lowton Business Park Newton Road St Marys Lowton Warrington WA3 2AP**, which is also our main trading address. Our VAT number is 825701244

2. Terms of Website Use
